Males, please have your hair neat and out of your eyes/face. All those who audition should wear ballet slippers. If you are proficient on pointe, please bring your pointe shoes, as you may be asked to perform additional choreography.

**Production Fees:**

There will be a mandatory production fee of \$100 per person. For those with more than 1 family member cast, there will be a 25% reduction of the fee for each additional cast member. This fee will cover costuming and general production costs. It is due, in cash, at the Cast/Parent meeting.

**Casting Results:**

Those at the July 14<sup>th</sup> audition, may receive a call back to the August 11<sup>th</sup> audition. We may need to see the dancer with a different group or for further review. Final casting results (for non – principal roles) will be posted on the L'Académie website, [www.lacademieofdance.com](http://www.lacademieofdance.com), Saturday, August 18<sup>th</sup>, no earlier than 5:00 pm. Please do not call the studio to confirm your results, view the website.
